Gus Solomons, Jr. has been director of his own troupe since 1966 and was previously a member of the dance companies of Martha Graham, Pearl Lang, Donald McKayle, Joyce Trisler, and Paul Sanasardo, before joining Merce Cunningham in 1965. He is also believed to be the only major choreographer with a degree in architecture—he was a student at Massachusetts Institute of Technology in his native Boston, and simultaneously studied dance at the Boston Conservatory of Music, where he was introduced to the techniques of Mary Wigman. He maintains a teaching studio in New York and was formerly on the faculty of the California Institute of the Arts.

Mr. Solomons was in residency at the University last season when he created a new piece for the U-M Dance Company which was performed in December. He will remain in Ann Arbor following tonight's concert through November 7 for teaching and choreographing another new work for performance by the U-M Dancers this coming December. In March he returns for another teaching residency and performance in *Carmina Burana* with the U-M Dance Company. Tonight's program is the first appearance of Mr. Solomons and his company under Musical Society auspices.
